# **DOA BEST PUBLICATION AWARD**

- 1) DOA has always encouraged research in all fields of orthopaedics. For promoting this cause, DOA has constituted one award each for the best publication in the stipulated year for researchers below 40years and above 40 years.
- 2) Each of the awardees shall receive a cash prize of Rs 5000 and a certificate during the Annual Conference of DOA.
- 3) Only DOA members are eligible for this award.
- 4) The members are requested to submit pdf reprint of their BEST RESEARCH PAPER published inPubmed Indexed Journal in the stipulated time period from 01/12/2021-30/09/2022
- 5) Only original research article shall be considered.
- 6) Case reports / review article / letter to editor shall not be considered for the award.
- 7) The DOA member may submit more than one application (Max two) of articles published in the current year.
- 8) An Article can be submitted by only one of the authors of the group which has published the article. Same article cannot be submitted for different categories.
- 9) The DOA member may specify the age category under which the Paper needs to be considered.
- 10) The Awards Selection Committee shall select the best publication on the basis of certain criteria like Impact factor of the journal, level of authorship, type (level) of study etc.
- 11) The decision of the committee shall be final.

# **DOA BEST PUBLICATIONS AWARD**

### Criteria:

### Impact factor (IF) of the journal where published:

- more than 2 IF: 5 points

1-2 IF: 3 points<1 point: 1 point</li>

1 extra point for being *first author* 

1 extra point for being corresponding author

In case of a tie, points shall be considered in the following order:

- i) Level of study
- ii) Impact factor of the journal
- iii) Author who is the first or corresponding author
- iv) Age of the member (Younger age preferred)
- v) Number of publications of same author in the stipulated time period (can be asked for later), number of publications in JCOT (official DOA Journal)
- vi) Still tied, then joint award.

The decision of the awards committee shall be final.

## Dr. PD Vaishya's best JCOT paper award of the year

To promote and encourage DOA members to contribute their fine research work in JCOT.

### Requirements:

1/ Life membership of DOA

2/ Publication in JCOT, in the past one year ( 01/12/2021- 30/09/2022)

3/ No. of read/downloads (in the past year)

#### Award:

1/ Amount of Rs. 11,000 2/ Certificate/Citation



### **Citation:**

*Dr. P.D. Vaishya* was born in 1934 at Gwalior to a wealthy business family. Due to some unavoidable circumstances, he was forced to study and was the first member of the household to go to college. His inspiration and influence followed in the family, and now not only his three successive generation but 35 family members are doctors, including 3 Orthopaedic Surgeons.

He got admitted for MBBS at Gajra Raja Medical College, Gwalior in 1955 and continued here to complete his MD (Medicine) in 1963. He was the first postgraduate physician in Gwalior to go into the private practice and was an immensely popular and respected physician of the city.
